### EXPERTISES

The EXPERTISE consists in determining the exact genealogy of a stamp: its catalogue number, its color, its authenticity.

In order to expertize your stamps or letters under the best of conditions, I will ask you to read the rules stated below and to follow them.

The items to be expertized can be mailed or delivered.

You can drop the stamps in our office.

If mailed, send them by registered mail or declared value with return receipt if you so wish. Plan for adequate protection without multiplying envelopes or cardboard. Never use scotchtape.

Once the expertise is done, you will be informed and the cost of the expertise will be indicated. The stamps will be at your disposal or mailed upon receipt of the honorarium.

Make a list of the stamps, a maximum of 15, use reverse side of this form. Put only one item per line and preferably use the Yvert catalogue. A first selection is recommended in order to eliminate stamps of little value and very damaged. You may use photocopies of this form.

Giving an exact length of time for expertizing is impossible since its varies with particular circumstances.

No pricing can be given for any items submitted for expertise.

Certificates with photographs, numbered and archived, can be made for particularly rare stamps, to specify a shade, a printing or a valuable cover. The cost is 30 € by certificate to be added to the expertizing fees.  
Attests with photographs, without number, can be made for stamps or covers wicth the value is almost 150 €. The cost is 10 € to be added to the expertizing fees.

AUTHENTIC stamps without flaws or alterations are given the expert signature in BLACK.

AUTHENTIC DEFECTIVE valuable stamps are given the same signature but in RED.

I reserve the right to decline expertization of stamps or philatelic documents for which i do not have adequate documentation and to refuse any request for expertization to persons who do not accept all the conditions stated on this form.

The expertization is made with almost care based on a very important documentation and on present knowledge. The responsibility of the s.a.r.l. jf-b Philatelie nor that of Jean-François BRUN cannot be challenged beyond the cost of the expertise.

In case of contest, only Paris tribunal will have final jurisdiction.

**Certificate:** 30 € in addition, Attest, 10 €, in addition.

**Minimum by expertise: 35 €**

Specialised classification or individual research + 50 %
